Time: Tentative Times 8-4 (finalized with registrations)

Rider Fee: \$175 per ride includes lunch. Stabling \$25/day.
(Not a WDCTA member \$185 per ride)

Auditor Fee: \$20/ day, \$30 / two days. Lunch Included.
(\$15/day and \$25/two days KM members)

Walk-in Auditors are welcome.

Advance notice would be appreciated for planning purposes.

(If delivered early it will have same consideration as opening day postmark)

Riders will be notified of selection results by: Jan 24th

Additional Requirements and/ or Issues:

1. WDCTA and Farm waivers will be signed by riders and auditors upon arrival.
2. All riders must wear an ASTM/SEI approved helmet at all times while mounted.
3. Coggins will be checked upon arrival. Coggins needs to be within one years' time.
4. Proof of Flu/rhino within 6 months.
5. Horses may arrive after 3 pm on Friday.
6. **No Refund** after rider selection unless a substitute rider is found by the selection committee or rider has a replacement horse they will be riding or replacement rider for their horse.
7. KM reserves the right to cancel clinic with refunds due to unforeseen events (weather, etc.).
8. Grooms are required to register as an auditor.

Selection Process (only used if clinic oversubscribed):

The selection process will only apply if the clinic is oversubscribed. Rosebury Farm can accommodate stabling for five outside horses for the clinic. In order to accommodate the limited stabling two sets of selections will be used. The selection process will be the same for both clinic boarders up to 4 riders and for the additional five riders who may or may not be boarders of Rosebury Farm.

In general the selection process will be as follows:

1. Completed registration and payment received after opening and before closing date. Coggins and proof of 6 month flu/rhino checked before unloading horse.
Priority will be given to those that meet the following criteria regardless of registration date.
2. WDCTA Member
3. KM Chapter Members have preference over members of other chapters.
4. KM volunteer participation
5. If a tie for all of the above criteria is achieved by multiple riders then a random drawing will be used.
