## **Additional Requirements and/ or Issues:**

1. WDCTA and Farm waivers will be signed upon arrival if not before.
2. All riders must wear an AST/SEI approved helmet at all times while mounted.
3. Coggins within one year will be checked upon arrival. Proof of previous 6 month flu and rhino.
4. Horses may arrive after 3 pm on Friday.
5. **No Refund** unless organizer is able to fill the ride time. Filling ride time may depend on stall availability.
6. KM reserves the right to cancel clinic or reschedule the clinic if under subscribed, illness, disease, or any other circumstances beyond organizer's control. All fees will be returned if cancelled or rider not selected. If clinic is re-scheduled rider has option of refund.
7. Grooms are required to register as auditor.

Opening Date: Dec 15, 2018

Riders will be notified by email of selection results by: Jan 28<sup>th</sup>

## **Selection Process (only used if clinic oversubscribed):**

The selection process will only apply if the clinic is oversubscribed. Rosebury Farm can accommodate stabling for five outside horses for the clinic. In order to accommodate the limited stabling two sets of selections will be used. The selection process will be the same for both clinic boarders up to 5 riders and for the additional five riders who may or may not be boarders of Rosebury Farm.

In general the selection process will be as follows:

1. Completed registration with full payment.
2. Two clinic rides – (Sat and Sun)
3. WDCTA Member
4. Non-Member
5. One clinic ride
6. KM volunteer participation as determined by organizer.

*If a tie for all of the above criteria is achieved by multiple riders then a random drawing will be used*
